The Hirer agrees and acknowledges:

- (a) I fully understand and agree to the effects of and my obligations under the Motorcycle Hire Agreement which includes the Terms and Conditions on the reverse hereof and/or attached hereto;
- (b) I authorise Sunset to debit my credit card with any charges arising out of this Motorcycle Hire Agreement which includes the Terms and Conditions;
- (c) I remain responsible for and authorise Sunset to debit my credit card for the cost of any speeding and parking fines incurred during the period of hire;
- (d) I remain liable for the full payment of the agreed hire period even if I return the motorcycle early;
- (e) My drivers licence or that of the nominated rider, details of which are above recorded, is legally enforceable and current in the country of issue and has not been revoked, cancelled or expired in any way and is the correct class for the type and size of motorcycle hired. I also have the appropriate amount of riding experience for the motorcycle that I am hiring or confirm that the nominated rider has the appropriate amount of riding experience as aforesaid;
- (f) I will not permit any other person other than the nominated rider, if different to myself, to ride the motorcycle;
- (g) I or the nominated rider (if any) am familiar with, understand and will adhere to the road traffic rules and regulations;
- (h) Neither I nor the nominated rider (if any) will not operate the motorcycle, or permit it to be operated, in breach of any legislation or By-Laws relating to road traffic;
- (i) I will pay to Sunset 0.25 cents for each kilometre I use the motorcycle in excess of 400 kilometres per day;
- (j) I will return the motorcycle with a full tank of fuel or I agree Sunset will debit my credit card with the cost of refuelling the motorcycle at \$[ ] per litre which I accept as the reasonable costs of Sunset refuelling the motorcycle;
- (k) I or the nominated rider (if any) will wear the helmet / equipment hired to me or the nominated rider (if any) by Sunset during the Period of Hire whilst I am or the nominated rider (as the case may be) is on the motorcycle and report to Sunset any impact that occurs to the helmet whilst it is in my or the nominated rider's care. I also acknowledge that I or the nominated rider (if any) may wear my or his/her own helmet provided it is in good condition and meets the appropriate and up to date Australian Standards;
- (l) I will pay a deposit of \$[ ] which will be refunded to me after any speeding, parking fines, minor damage or insurance excess has been paid for;
- (m) I will pay an excess of \$[ ] in the event of any loss or major damage to the motorcycle hired;
- (n) I acknowledge receipt of the Motorcycle Condition Report;
- (o) I will not drive the motorcycle or cause it to be used above the 26th Parallel; and
- (p) In the event that I am not the nominated rider as well as the Hirer, I acknowledge and understand that I will be legally responsible for actions of the nominated rider as if he or she were referred to as the Hirer in this document and the Terms and Conditions of Hire.
